Since 2008 the ORE TimeBank has recorded more than 36,000 hours of exchanges of services in more than 12,000 individual exchanges. In 2014 the ORE Timebank had 800 members from 65 towns and cities in central Vermont. The offers and requests listed in the timebank are very diverse. See <http://orexchange.timebanks.org>. Each service is worth the time you spend providing or receiving it. The hours banked are based on the premise that everyone's time is valued equally.
